**From Mass Pike** – Take Exit 11A (495) Go south one exit to 21B towards Upton. After 5.7 miles, cross over Rte 140 and at the next traffic light, take a left on Pleasant St, Nipmuc Regional is a short distance on the right. Park behind the school. Registration is in the cafeteria (rear of the school)

**From 495** – Take exit 21B and proceed as above.

**From Rte 140:** From Milford Area. After Upton Town Common and approx. 0.5 miles, bear left onto Pleasant Street to "Valley Tech." Continue on to Nipmuc Regional.

Or From Worcester Area, enter West Upton. Turn right at traffic light (Maple Street) Then 0.75 miles take a left on to Pleasant Street. Follow signs. Nipmuc Regional is on the right.
